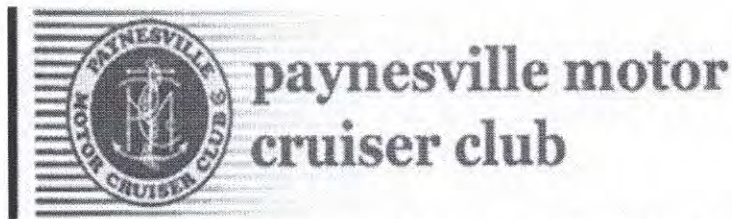
On a local level, Bob has been involved

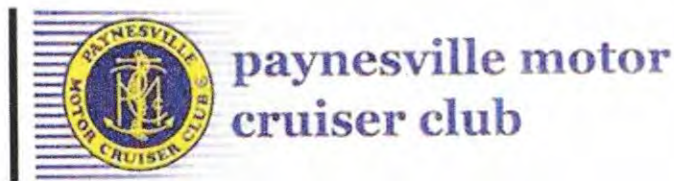

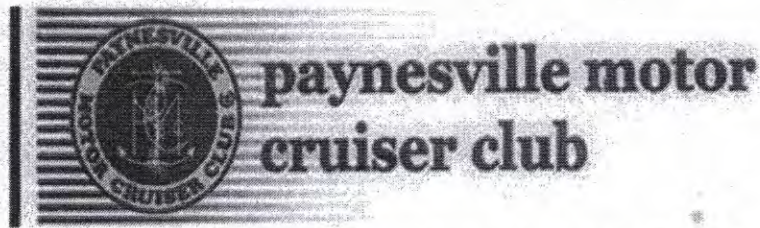

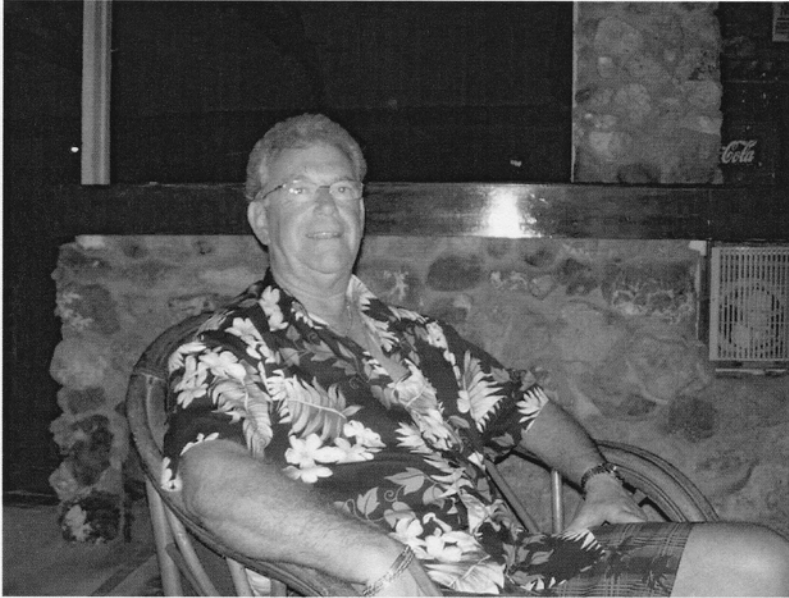

This Club has a great future under my commodore ship, we have a venue that is second to none, we will have great times and fun on the way, our members deserve a committee they are proud to have and fun to be with.

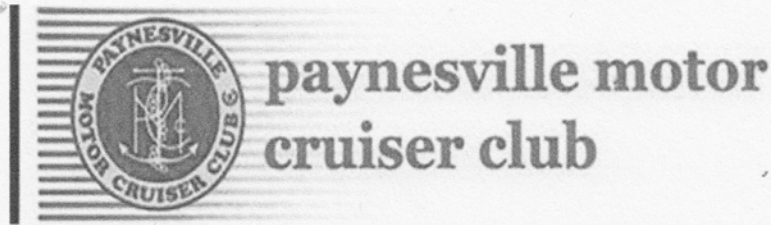

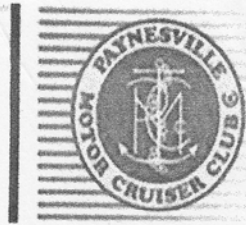
I believe the future of this club is family and the next generation and to create memories forever and fun times as a team effort .

I believe the Paynesville Motor Cruiser Club is a fantastic venue for our members and the wider community, there are not many venues, with a better view.

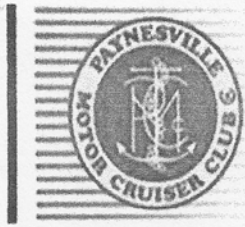
